- 2.4.6 Some headings and/or labels describing topics or purposes are missing;
- 1.2.1 For some pre-recorded audio-only or video-only media, no time-based media alternatives have been provided containing information equivalent to the pre-recorded audio-only or video-only content.
- 4.1.2 For some user interface components (including form elements, links, and script-generated components), the name and role have not been programmatically determined; states, properties, and values, when user-defined, should be programmatically settable; and notifications of state changes for these elements should be displayed by user programs, including assistive technologies.
- 1.1.1 Some non-text content presented to the user does not have an equivalent text alternative that serves the same purpose;
- Any other changes to the site will be included in future plans by the relevant company departments.
