

TREASURY SHARE PURCHASE TO SERVE THE COMPENSATION PLANS BASED ON FINANCIAL INSTRUMENTS APPROVED BY CERTAIN SUBSIDIARIES OF UNIPOL ASSICURAZIONI

Bologna, 24 February 2026

With reference to the today's press release concerning the launch of the purchase programmes (the “Programmes”) of treasury shares of Unipol Assicurazioni S.p.A. (the “Shares” and “Unipol”) by the following directly controlled Unipol’s companies: Arca Vita S.p.A., Gruppo UNA S.p.A., I.Car S.r.l., UnipolAssistance S.c.r.l., UnipolService S.p.A. e UnipolTech S.r.l. (the “Subsidiaries”) to serve the compensation plan 2022-2024 based on performance share type financial instruments for the managers, please note the following.

In accordance with article 5, third paragraph, of Regulation (EU) 596/2014 and article 2, third paragraph, of Delegated Regulation (EU) 2016/1052, the Subsidiaries purchased a total of 28,700 Shares (equal to approximately 0.004% of the Unipol share capital) on the regulated market on today's date, for a total of € 609,301.

In accordance with the above-mentioned regulatory provisions, the detailed lists of the individual purchases of the Shares (code ISIN IT0004810054) are attached indicating the quantity and the respective prices and when the transactions were carried out. The Subsidiaries has concluded the Share purchase Programmes through the above-described transactions.

As of today’s date, Unipol holds a total of 2,338,130 ordinary treasury Shares (equal to approximately 0.326% of the share capital), of which 2,151,147 directly and 186,983 indirectly through the following subsidiaries: Compagnia Assicuratrice Linear S.p.A. (14,743), Arca Vita S.p.A. (5,747), Leithà S.r.l. (5,239), SIAT S.p.A. (13,493), UniSalute S.p.A. (11,735), UnipolRental S.p.A. (6,656), UnipolAssistance S.c.r.l. (5,691), Assicoop Bologna Metropolitana S.p.A. (104,479), Gruppo UNA S.p.A. (3,200), UnipolTech S.p.A. (9,800), I.CAR S.r.l. (4,200) and UnipolService S.p.A. (2,000).
