



“Russia 1917 – One hundred years that changed the world”: the latest cultural event organised by Fondazione Musica Insieme in partnership with the Unipol Group

The words and music of artists who symbolised the epochal event performed during four evening shows at the Unipol Auditorium.

Their verses will be accompanied by the works of composers who also lived the dramatic events of the revolution.

The poems will be read aloud by renowned Italian actor Luigi Lo Cascio and the music will be performed by pianist Alexander Romanovsky, accompanied by the stunning voice of Olga Peretyatko-Mariotti, violinist Alexandra Soumm and cellist Miriam Prandi.
